TERMS AND CONDITIONS

The following terms and conditions are an integral part of this Application for Bail Bond. Power Number(s) _____, for which AMERICAN SAFETY CASUALTY INSURANCE COMPANY (hereinafter called SURETY), or its producer shall receive a premium in the amount of _____ dollars (\$ _____), and the parties agree that said appearance bond(s) is conditioned upon full compliance by the principal of all said terms and conditions and is a part of said bond(s) and application therefore.

1. At any time before there has been a breach of the undertaking in any type of bail or fine and cash bond the SURETY may surrender the defendant to the sheriff of the county in which the defendant is bonded to appear or to the sheriff where the defendant was bonded; in such case the full premium shall be returned within 72 hours after the surrender. The defendant may be surrendered without the return of premium for the bond if the defendant does any of the following:

- (a) Willfully fails to pay the premium to the SURETY or willfully fails to make a premium payment under the agreement specified in G.S. 58-71-167 or its successor.
- (b) Changes his or her address without notifying the surety before the address change.
- (c) Physically hides from the SURETY.
- (d) Leaves the State without the permission of the SURETY.
- (e) Violates any order of the court.
- (f) Fails to disclose information or provides false information regarding any failure to appear in court, any previous felony convictions within the past 10 years, or any charges pending in any State or federal court.
- (g) Knowingly provides the SURETY with incorrect personal identification or uses a false name or alias.

2. The undersigned hereby warrants that the foregoing declarations made and answers given are the truth without reservation and are made for the purpose of inducing the SURETY to become surety or to procure suretyship on the bond or undertaking applied for herein, with the intent and purpose that they be fully relied.

3. For good and valuable consideration, the undersigned hereby agrees to indemnify and/or hold harmless, SURETY, Lexington National Bail Services, Inc. and/or its producer for any and all losses related to issuance of the bond. In addition, the undersigned does hereby waive any and all rights it may have under Title 28 Privacy Act – Freedom of Information Act, Title 6, Fair Credit Reporting Act, and any such local or State law, and further consents to and authorizes the SURETY, and/or its agent, to obtain any and all private or public information and/or records concerning the undersigned from any party or agency, private or governmental (local, State, Federal), including, but not limited to, credit reports, Social Security Records, criminal records, driving records, telephone records, medical records, school records, worker compensation records, and employment records. Each authorizes, without reservation, any party or agency, private or governmental (local, State, Federal), contact by SURETY, and/or its agent, to furnish any and all private and public information and records in their possession concerning the undersigned to SURETY, and/or its agent, and directs that a copy of this document shall serve as evidence of said authorization.
